The progressive digitalization of business processes poses new threat and risks for companies regardless of company size and sector. Also in Austria the number of cyberattacks is increasing. Especially SMBs underestimate this risk and the associated potential damage. In the event of damage, costs after an attack quickly exceed the 100,000 euro mark.

### EXAMPLES OF DAMAGE

Loss of hardware like laptop, smart phone, USB stick, hard disk, CD, etc.	An employee's laptop was stolen and sensitive data got lost. This leads to a breach of confidentiality and data protection.  An employee leaves the company and steals hardware with sensitive data.
Data loss	Your IT systems have been attacked by a third party. Hackers can access client data e.g. payment details of your customers over several months.
Electronic theft (spy ware)	Third parties gain access to your sensitive data and documents and steal them. The saved data and programmes need to be replaced. This results in high costs and labour input.
Business interruption	Failure of your IT systems due to a security problem. A decrease in revenue and a damaged reputation are the result.


